I HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE EFK or any of its managers, coaches, players, participants, officials, members of its Board of Directors, committee members, facility owners and lessees, sponsors, advertisers, volunteers, employees, agents, and all persons assisting in the conduct of EFK activities or events, (all of whom are herein collectively referred to as the RELEASEES), FROM ALL LIABILITY FOR ANY AND ALL PRESENT OR FUTURE LOSS OR DAMAGE, AND ANY CLAIMS, DEMANDS, AND CAUSES OF ACTION (hereinafter LIABILITY) ON ACCOUNT OF ANY PERSONAL INJURY, INCLUDING RESULTING IN DEATH, OR PROPERTY DAMAGE, ARISING OUT OF OR RELATED TO ANY EFK EVENT OR OTHER ACTIVITY; and from any cause whatsoever, including, without limitation, the failure of anyone to enforce rules and regulations, to make inspections, the condition of any portion of the facilities or premises, defective products, any act or omission of the RELEASEES, or any other act WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. This release, waiver, discharge, and covenant not to sue also expressly covers all LIABILITY in any way related to my presence, or the presence of Participant, for any reason at the facilities of EFK or on the premises where the EFK events and/or activities take place, including as a spectator, and includes transportation to and from the activities and events. 2. I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them FROM ANY LOSSES, DAMAGES, INJURIES, DEBTS, LIABILITIES, EXPENSES (including court costs and attorneys fees), JUDGMENTS, OR COSTS they may incur due to claims, demands, damages or causes of action brought against the RELEASEES on account of any injury, including but not limited to, death or damage to property, caused or alleged to be caused in whole or in part by the negligence RELEASEES or otherwise arising from or related in any way to any EFK event or activity. 3. I HEREBY AGREE TO furnish acceptable proof of the Participant's age and residence to the League President upon request. 4. I HEREBY AGREE TO abide by the policies and procedures of EFK. 5. I UNDERSTAND AND ACKNOWLEDGE that the Participant must either: (i) reside within the boundaries of EFK, or (ii) attend a school that is located inside the boundaries of EFK, in order to

participate in EFK programs. I acknowledge that any misrepresentation of residence or school attendance within league boundaries will result in the Participant's expulsion from the program without refund. 6. I HEREBY give permission to EFK, to use photographs and video taken of Participant during the games and events associated with EFK in any manner to help promote the league activities. Such use could include publications, media releases, announcements, electronic or otherwise, and on league websites or social media pages. I understand that neither I nor Participant will receive any compensation if such image appears in any of the manners listed above or other manner that the league deems appropriate. I agree that such image is the property of EFK. 7. I HEREBY REPRESENT AND WARRANT that I am the parent or legal guardian of the Participant, and that I am legally authorized to enter this agreement on behalf of the participating child. ## Player / Parent Code Of Conduct

PLAYER / PARENT CODE OF CONDUCT PARENTS/PLAYERS CODE OF CONDUCT: We, EN FUEGO KIDS (EFK), have implemented this Parent Code of Conduct for the important message it holds about the proper role of parents in supporting their child in sports and in furtherance of a purpose of Little League, which is to assist youth in developing qualities of citizenship, discipline, teamwork and physical well-being, with proper guidance and exemplary leadership. EFK is dedicated to providing a safe and fun atmosphere for the children participating in league events and ensuring the safety of officials, volunteers and spectators as well. Parents should read, understand and sign this form prior to their children participating in our league. Also, if you bring friends and relatives to league events, we ask that you inform them of league policy concerning acceptable behavior at league events before you arrive at the fields. The essential elements of character-building and ethics in sports are embodied in the concept of sportsmanship and the highest potential of sports is achieved when competition reflects these six values: 1) Trustworthiness, 2) Respect, 3) Responsibility, 4) Fairness, 5) Caring, and 6) Good Citizenship. I therefore agree: 1. I will remember that children

participate to have fun and that the game is for youth, not adults. 2. I will not force my child to participate in sports. 3. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others. 4. I will learn the policies of the league and the rules of the game. 5. I will promote the emotional and physical well-being of the athletes ahead of any personal desire I may have for my child to win. 6. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sporting event. 7. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing and taunting, yelling at or trying to initiate communication with an official or coach during a game, or using profane language or gestures. 8. I (and my guests) shall accept all decisions of the umpires and officials as being fair and judged to the best of their ability. 9. I will not encourage any behaviors or practices that would endanger the health and well-being of the athletes. 10. I (and my guests) will respect the officials and their authority during games and will never confront coaches at the game field, and will take time to speak with coaches at an agreed upon time and place. I agree to a 24 hour cooling off period before holding a discussion with a coach or manager. 11. I will teach my child to play by the rules and to resolve conflicts without hostility or violence. 12. I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability. 13. I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of a game or his/her performance. 14. I will praise my child for competing fairly and trying hard. 15. I will never ridicule or yell at my child or other participants for making a mistake or losing a competition. 16. I will emphasize skill development and practices and how they benefit my child over winning and de-emphasize game results. 17. I will demand a sports environment for my child that is free from alcohol, drugs and tobacco, and I will refrain from their use at all sports events or anywhere at or near the vicinity of the EFK fields. 18. I will refrain from coaching my child or other players during games and practices, unless I am one of the official coaches of the team and on in the dugout or the field with the players. I also agree that if I fail to abide by the aforementioned rules and guidelines, I may be subject to disciplinary action.
